



Busty Bunny Entertainment -Age Verification & Safety Policy

1. Purpose and Scope

This Policy outlines Busty Bunny Entertainment's obligations and practices regarding age verification, online safety, and compliance with Australian law.

Busty Bunny Entertainment is an adult entertainer directory, not an escort agency, and we do not facilitate sexual services. Our services are exclusively for individuals aged 18 and over.

This Policy applies to:

- All website visitors, clients, and entertainers.
 - All content on our platforms.
 - All booking and contact processes.

2. Legal and Regulatory Framework

Busty Bunny Entertainment operates in full compliance with relevant Australian laws, including:

- **Online Safety Amendment (Social Media Minimum Age) Act 2024:** This requires online platforms to enforce minimum age rules from 10 December 2025.
- **eSafety Commissioner Codes:** These mandate that sites hosting adult content implement reliable age verification to prevent access by minors.
- **Privacy Act 1988 (Cth):** This governs the collection, use, and storage of personal information.

We will continuously monitor and update this Policy to reflect changes in the law.

3. Age Restriction and Verification

3.1 Strict 18+ Access

Access to the adult sections of our website and all booking services is strictly limited to individuals 18 years of age or older. Minors are prohibited from accessing adult content or booking entertainers.

3.2 Verification Methods

To verify a user's age, Busty Bunny Entertainment may utilize:

- Government-issued ID checks.
- Secure third-party age verification services.
- Payment card verification.

All verification data is handled securely and retained only for as long as necessary.

4. Content Display and Safe Search Standards

All images on our website fall within the Google SafeSearch framework. Our content is suggestive but not pornographic or explicit. Any content requiring additional discretion is clearly labeled as 18+. We ensure that no content that could be accessed by minors is displayed through general browsing.

Any MP4 videos on third-party platforms, such as YouTube, are uploaded in compliance with **YouTube's Safe to View guidelines** and are labeled as 18+ and restricted for viewing.

5. Booking and Contact Processes

The only approved booking methods are:

- The official booking form on our website.
- The verified telephone number: +61 0439959255.

We do not accept bookings via social media direct messages or unverified third-party channels. All booking requests require clients to confirm they are over 18.

6. Interaction with Minors

Busty Bunny Entertainment has a zero-tolerance policy for interactions with individuals under 18. Any attempt by a minor to access our services will result in immediate termination of access and may be reported to the relevant authorities.

7. Entertainer and Client Safety Protocols

All entertainers are identity-verified and confirmed to be over 18. We have robust safety protocols in place to protect entertainers during bookings and to ensure client accountability. Entertainers are trained on how to report any concerns or policy breaches. Clients who engage in unsafe, unlawful, or underage activity will be permanently barred from our services.

8. Privacy and Data Handling

We collect only the minimum data required for age verification and bookings. This data is stored securely, with restricted access, and is deleted when no longer needed. Busty Bunny Entertainment fully complies with the Australian Privacy Principles.

9. Monitoring and Compliance

This Policy will be reviewed annually and updated in accordance with changes to laws or eSafety requirements. We will conduct regular audits to ensure our booking forms, age gates, and content filters remain compliant. Any breaches of this Policy will be promptly investigated and addressed with corrective action.

10. Transparency and Reporting

Users will be clearly informed of 18+ restrictions upon accessing our website. We will provide a clear process for clients, entertainers, or members of the public to file complaints and reports.

We will review the image immediately, and if necessary, it will be taken down and an appropriate replacement will be used. Our goal is to work with the community to ensure both our customers and performers are supported and protected.

Busty Bunny Entertainment will cooperate fully with the eSafety Commissioner and other regulators as required.
